SUBJECT: Publication and Distribution of Final Product Service Code to Object Class Code Crosswalk, Version 1.0

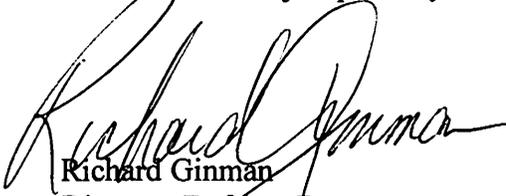
In order to improve the collection and reporting of information related to obligations and expenditures, DoD components should use both the Standard Financial Information Structure (SFIS) element Product Service Code (PSC) and the SFIS element and Office of Management and Budget (OMB) Object Class Code (OCC) to categorize products and services the Department purchases. Associating PSCs to OCCs links budget and expenditure data, and enables DoD to minimize errors and improve electronic commerce.

As directed by the January 14, 2014, USD(AT&L) memorandum (Reference (a), available at www.acq.osd.mil/dpap/policy/policyvault/USA005536-12-DPAP.pdf), the Office of the Under Secretary of Defense for Acquisition, Technology, and Logistics (OUSD(AT&L)) partnered with OUSD(C) to create the operational crosswalk between the PSCs used by the procurement community and OMB-defined OCCs used in the financial community. The PSC-to-OCC crosswalk version 1.0 is now available for download at www.acq.osd.mil/dpap/pdi/p2p/index.html. Version 1.0 applies to the contract pay and vendor pay assessable units within the Procure-to-Pay end-to-end (E2E) process. Updates to incorporate other E2E processes are forthcoming.

The crosswalk's intent is to improve alignment between execution and budget data in response to Federal Transparency initiatives and to support DoD cost management and E2E process initiatives. To accomplish this, the PSC and OCC should be recorded at the Purchase Request line item level to link the point of commitment and obligation. This will align financial transactional data with respective contract award data, which contains the PSC in accordance with Defense Federal Acquisition Supplement Procedures, Guidance and Instructions 204.7103. The crosswalk was coordinated and all comments were adjudicated in response to Reference (b).
